1. Update on actions from last meeting

Agenda item 2. Developing the business case

General points:

The development of the business case for phase II of MCCIP was the key discussion item for the day. It was agreed that it needed to be strong on selling our success on how MCCIP has changed behaviour and developed new approaches that are been taken up by other groups both in the UK and overseas.

We should push the fact that we have worked to reduce lag time of getting evidence from science to policy to essentially a one year cycle. We should also push the co-ordination of effort that has gone into the process and proving things like confidence rating which have been widely regarded as useful. We should also stress that MCCIP was borne out of charting progress 1 due to a lack of evidence on marine climate change and that charting progress 2 will have a whole chapter on marine climate change now.

Strategic context

It was agreed that we need to be clear in our overall aim that adaptation will be a key part of phase II, otherwise our overall aim is still based on impacts.

Moving forward, the evolution towards more adaptation work is similar to the journey that UKCIP has been on and it is a very different role to play. We need to consider you can't do everything; need to look at where resources are most usefully channelled.

Approach

There is a possible further dimension to our work that we need to emphasise on MCCIP advice (given our important role in providing advice to CP2, OSPAR, UKCP09 etc...)

With regards to the expanded programme for phase II, the concept of climate smart working was raised. The relationship between climate smart working and adaptation was clarified, which was essentially a more attractive repackaging of evidence and risks but that would inevitably involve some discussions of what mitigation work communities are doing too.

The move to a 'facilitation' role rather than science was discussed and if was felt that it was very different to what we had done before. The amount of time taken to get to this point from impacts to adaptation shouldn't be underestimated and some concerns were raised about adequately resourcing this additional workstream.

Suggested we should run a 'pilot' climate smart report and see what resource requirements are from this and move on. Pilot needs to be cross cutting enough to draw interest in from a wide audience but be focussed enough that it means something (i.e. by having a pilot we can articulate concept to a wide base of people and show how it can be applied to a sector / community). If we pilot as a card can we do some complimentary work in the ARCs too on adaptation as part of badge that we are increasing our work here?

It was stressed that implementing adaptation options is only part of the process, building adaptive capacity through networks and understanding barriers to adaptation and other aspects like this are important too.

Other business case issues

It was agreed that a one page summary of benefits for partners was useful to go alongside the business case to provide a background to the partnership and the current document should be brought up to date with an expanded remit. It should also include a paragraph on what's new to help enhance case for increased funding.
